**Invitation for Expression of Interest (EOI)**

Expression of Interest (EOI) affixing court fee of Rs. 8.25/- (Rupees Eight and Twenty Five Paise) only is hereby invited from retail pharmaceutical outlets located in the surrounding of GMCH campus for supply of essential medicines and surgical items required for treatment of patients admitted under RBSK Scheme in GMCH. The Proposal should be submitted in office of the Superintendent, Gauhati Medical College Hospital, Guwahati within 15 days from the date of publication of proposal.

**Details of Proposal:-**

1. The medicines & surgical items are required for patient bellow the age of 18 years admitted in GMCH under RBSK Scheme.
2. The Payment will be made on submission of bill monthly/patient wise in triplicate copy on satisfactory completion of supply subject to verification by concerned officers of GMCH and availability of fund.


**Eligible Criteria:-**

1. The outlet should be operating on 24X7 basis having valid drug license.
2. The outlet should be located in surrounding of GMCH campus (within 1 K.M. radius).
3. The outlet should have the ability to supply all type of medicines and surgical items as prescribed by treating doctor of GMCH. (In this context the bidder should submit a self declaration having ability to supply the medicines and surgical items as prescribed by the treating doctor of GMCH or as per requirement of hospital authority of GMCH).
4. The bidder should have knowledge about the RBSK scheme deeply.
5. Successful bidder shall come at an agreement of rate contract with Hospital authority.
6. The contract shall be valid for 1(One) year and extendable up to another one year on satisfactory performance of the first year.
7. The successful bidder has to submit the performance security (Refundable) of Rs. 20,000/- (Twenty Thousand only) in a lump sum amount in the form of Demand Draft/Banker's Cheque/Fixed Deposit receipt in favour of **GMC HOSPITAL NRHM**. The performance security shall be forfeited on breach of Rate Contract Agreement.

**Method of Selection:-**

1. The bidder shall quote the rate of discount for each category of items (As per Annex-I).
2. The bidder quoting the highest discount rate on MRP will be selected as the successful bidder (L1) and will be awarded the notification of award subject to fulfillment of all technical criteria.
3. **The bidders' shall quote the lowest MRP of the items amongst the different brands.**
