- Whereas M/S. Samanwaya Enterprise alongwith three other firms participated in the tender process and M/S. Samanwaya Enterprise was selected as L1 supplier.
- Whereas order was issued to M/S. Samanwaya Enterprise for supply of various stationary article vide No.MC/76/2019/313, dtd. 03/12/2021
- Whereas M/S. Samanwaya Enterprise failed to supply the article within the stipulated date causing immense trouble to the Gauhati Medical College in day to day maintenance of activities.
- Whereas remainder was also issued to the said firm to supply the articles immediately.
- Whereas the said firm submitted an undertaking to ensure supply within 7 days from 03/02/2022 failing which he agreed to oblige by the decision of the Principal, GMC.
- Whereas till date he has not supplied the articles ordered for thereby causing immense trouble to GMC beside causing loss by way of lapse of fund as the sanction of Rs. 8,41,167/- was made against his name vide Health & F.W. sanction order No.FS/DME_2021-22(I)_118, dtd. 28/10/2021

In view of the gross negligence on the part of M/S. Samanwaya Enterprise the following punitive action are ordered against the firm:

- 1. EMD. money of Rs. 20,000/- (twenty thousand) only deposited by the firm against the said contract is hereby forfeited.
- The said firm is debarred from participating in the tender process of Gauhati Medical College and Gauhati Medical College & Hospital for three consecutive financial year commencing from 01/04/2022
