Notice Inviting Quotation (NIQ)

Notice Inviting Quotation (NIQ) affixing court fee of Rs. 8.25/- (Rupees Eight and Twenty Five Paise) only is hereby invited from reputed vendors for SUPPLY OF ORTHOPAEDICS IMPLANTS (package wise) REQUIRED FOR DIFFERENT PROCEDURES UNDER ORTHOPAEDICS DEPARTMENT, GMCH, Guwahati-32, within 15 days from the date of publication of proposal.

Details of Proposal:-

1. The implants are required for the patients admitted in GMCH under PMJAY Scheme.
2. The Payment will be made on submission of bill monthly (patient wise) in quadruple copies alongwith receipt by concerned doctors of Orthopaedics Department of GMCH and subject to availability of fund.
3. The contract shall be valid till 31st March 2024 or till the finalization of next NIQ whichever is later at the sole discretion of authority of GMCH.
4. The bidders has to submit the Earnest Money Deposit (Refundable) of Rs. 30,000/- (Thirty Thousand only) in a lump sum amount in the form of Demand Draft/Fixed Deposit receipt in favour of **"Member Secretary, HOSPITAL MGMT. SOCIETY GMCH"** Gauhati Medical College Hospital, Guwahati-781032. The performance security shall be forfeited on breach of Rate Contract Agreement.
5. The hospital authority reserves the right to reject any or all the bids or part or not to award the contract to any bidder. The decision of the hospital authority in this regard shall be final and binding on all.

Eligibility Criteria:-

- a) The bidder must be a manufacturer or their accredited dealers (specifically against this NIQ for the subject goods). The bidder should have valid authorization letter (item wise/brand wise) from Principal Company/manufacturer for quoted items. In case of manufacturer, the required OEM certificate should be enclosed.
- b) The vendor's office location should be within 1 km. radius of GMCH.
- c) The bidder must have successfully executed contracts for similar and/or identical goods in the past 3 (three) financial years prior to the date of bid opening. In support of this, the bidder shall furnish previous Work Orders and Performance Certificates.
- d) The bidder should have the eligibility to deliver the supply items within **6 hours or less**. (In this context the bidder should enclose an affidavit in notarized stamp paper with requisite value).
- e) Bidder should have the eligibility to supply all the items listed within a package. Any alteration/quoting part of items of a package will not be accepted i.e., the package without quoting rate of all the items shall be treated as incomplete and will be rejected.
- f) The bidder should maintain an adequate stock of all the items (package wise) at any point of time.

The Documents required along with the proposal:-

1. Court fees of Rs. 8.25 GST and PAN
2. Valid Drug License.
3. Copy of ITR for last 03 years.
4. Valid Trade License issued by urban local bodies or other competent authority.
5. Literature/catalogue/leaflet in support of the tendered item
6. EMD amounting to Rs. 30,000.00 (Thirty Thousand) only in favour of **"Member Secretary, HOSPITAL MGMT SOCIETY GMCH"**
7. Up to date dealer/ distributor certificate.
8. Authorized signatory should specifically sign on each page of tender documents.
9. The bidder should submit a self declaration (notarized) having ability to supply the medicines and surgical items as prescribed by the treating doctor of GMCH or as per requirement of hospital authority of GMCH.
10. Interested Firms/Parties will have to submit unconditional acceptances to the above terms and conditions at the time of submission of the quotation on the letter head of the firm.
