# **Notice Inviting Quotation (NIQ)**

Notice Inviting Quotation (NIQ) affixing court fee of Rs. 8.25/- (Rupees Eight and Twenty Five Paise) only is hereby invited from retail/wholesale pharmaceutical outlets located in the premises of GMCH campus for supply of essential medicines and surgical items required for treatment of patients admitted under RBSK Programme in GMCH. The Proposal should be submitted in office of the Superintendent, Gauhati Medical College Hospital, Guwahati-32.

### **Details of Proposal:-**

- 1. The medicines and surgical items are required for patient below the age of 18 years admitted in GMCH under RBSK Programme.
- 2. The Payment will be made on submission of bill monthly (patient wise) in triplicate copy on satisfactory completion of supply subject to verification by concerned officers of GMCH and availability of fund.
- 3. The Hospital authority reserves the right to reject any or all the bids or part or not to award the contract to any bidder. The decision of the hospital authority in this regard shall be final and binding on all.

### **Eligibility Criteria:-**

- 1. The outlet should be operating on 24X7 basis having valid drug license.
- 2. The outlet should be located in premises of GMCH campus.
- 3. The outlet should have the ability to supply all type of medicines and surgical items as prescribed by treating doctor of GMCH. (In this context the bidder should submit a self declaration having ability to supply the medicines and surgical items as prescribed by the treating doctor of GMCH or as per requirement of hospital authority of GMCH).
- 4. The bidder should have knowledge about the RBSK Programme deeply.
- 5. Successful bidder shall come at an agreement of Rate Contract with Hospital authority of GMCH.
- 6. The contract shall be valid till 31<sup>st</sup> March 2025 or till the finalization of new NIQ whichever is earlier at the sole discretion of authority of GMCH.
- 7. The successful bidder has to submit the performance security (Refundable) of Rs. 50,000/- (Fifty Thousand only) in a lump sum amount in the form of Demand Draft/Banker's Cheque/Fixed Deposit receipt in favour of "Member Secretary, HOSPITAL MGMT SOCIETY GMCH" Gauhati Medical College Hospital, Guwahati-781032. The performance security shall be forfeited on breach of Rate Contract Agreement.
