 Copy of Registration certificate under Municipality bodies or other competent authority a copy of GST number along with latest income tax & sales tax clearance certificate should be attached with technical bid and valid drug license.

3. Conditional & telegraphic tenders shall not be accepted.

- 4. A notarized undertaking to the effect that the company/ firms/ distributor are not blacklisted should be attached with the tender.
- The rates should be quoted exclusive of GST mentioning the rate of GST. All tenders/ quotation will be deemed to be for F.O.R (Free on road) destination at Guwahati Medical College hospital, Guwahati including packing, forwarding the insurance charges and not be ex-work, ex-godown, ex-miles etc.
- 6. A person singing the tender form or any other document forming the part of contract on behalf of another shall be deemed to warranty that he has the authority to bind such order in a constitution of law and if on the enquiry it appears that the person so signing has no authority to do so, the purchase may without prejudice to other civil and criminal remedies against the contract, hold the signatory liable for all costs and damages and forfeit money.

The tender must be submitted in two parts (i) Technical bid (ii) Financial bid separately. All documents
required as per terms and conditions should be enclosed with technical bid only. Tender not received in

specified manner will be rejected.

8. Technical and financial bids are to be submitted separately in two sealed envelopes clearly indicating the technical bids and financial bids on the envelopes. Both the envelopes should be put in a common sealed envelope clearly superscribing the NIT no, date and names of the supplier on the body of the envelope.

9. The inner label as well as label on the catch cover/ carton shall bear conspicuously to wards, "Hospital supply, Not for sale" and bolder that those already printed on the label. The above caption shall run from the lower left corner to the top right hand corner. The lab/ cap/ bottle etc. Should have mark of "Hospital supply, not for sale".

10. Bid Guarantee and security

- (a) The tender must be accompanied with refundable money of Rs. 20,000/- (Rupees twenty thousand only) in a lump sum amount in the form of Demand draft/ banker's cheque/ Fixed deposit receipt in favour of The Principal cum chief superintendent and Secretary, GMCH, payable at Guwahati. Earnest money in the other form will not be accepted. Bids not accompanied by earnest money as started above or less than the amount stipulated above shall be summarily rejected.
- (b) Earnest money/security deposit any other sums of the tenders lying with the Gauhati Medical College hospital, Guwahati in connection with any other tender/ case will not be considered against this tender.
- (c) The successful bidder shall be required to furnish performance security of Rs. 20,000/- by the firm in the form of fixed deposit receipt duly hypothecated in favour of The Principal cum chief superintendent and Secretary, GMCH, Guwahati. The performance security will be forfeited on the violation of tender norms and failure to supply in time by bidder.

(d) Earnest money deposit by unsuccessful bidders will be refunded after completion of tender process. EMD submitted by successful bidder will be converted as performance security automatically.

- (e) In case of successful bidder is found in breach of any condition/ tender at any stage, legal action as per rules/ laws shall be initiated against the agency concerned. In that case EMD/ performance security shall be forfeited after giving proper opportunity through show cause notice.
- 11. The work/ supply order will be placed as and when requirement arises from the concern department and payment will be made subject to availability of fund after observing all necessary formalities. Any claim for the advance payment will not be entertained. No interest will be allowed for late payment.

12. The maximum delivery period from the date of placing the order should be specified. There after this institute will be forced to charge 5% of the cost of items for each 10 days or part of it as penalty till receipt of the materials.

- 13. All quotation/ tender should be deemed valid for least of one year from the date of completion of comparative statement of the tender. However, the same can be extended for another period of 01 (one) year or till the finalized of new tender whichever is earlier subject to sole discretion of authority of GMCH.
- 14. Any request for increase in the approved basis rate (excluding tax) will not be entertained for any reasons for the contract period for any reason and the items required to be supplied by contractor should strictly be in accordance with the sample approved.

- 15. The inspection for goods will be carried out by the consignee at destination & rejected goods will have to be removed by you within 10 days of dispatch of advice from the undersigned failing which goods will live at own risk.
- 16. The rejected goods must be replaced by you within 7 days from the date of notice, intimating that the goods have been rejected. Failing to supply the materials as per approved standard will be considered for cancellation of contact/black listing of the firms for at least 3 years.
- 17. The supply must be completed satisfactory within the stipulated period, failing which the store purchase Officer / chairman purchase committee reserve the right to purchase or allow the indenting officer to purchase goods at risk provided that where goods were not supplied accordingly to the master pattern & not in accordance of the demand the indenting officer decides to retain the inferior goods.
- 18. The bidder should enclose latest tender specific original authorization certificate from the original manufacturer or its Indian firm which the technical bid, failing which the tender are liable to be rejected straightway. The bidder must be dealing in system packs for auto analyzed.
- 19. There should be provision for supplying immediately on emergency basis as and when necessary.
- 20. (a). Bidder quoting multiple rates with multiple samples against one items shall be consider as non responsive for all purpose.
 - (b) Samples are to be submitted as and when called for. Single sample with single rate is to be submitted against single items at the time of sample verification. Quotation multiple rates and submitting multiple samples for a single items will summarily be rejected.
- 21. The items required to be supplied by contractor should strictly be in accordance with sample approved.
- 22. The material shall not be consider delivered until it is approved & received by the competent authority as defined from time to time by purchase committee.
- 23. The bidder shall certify that the rates quoted as the lowest ones for any institution (Govt. of Private) in
- 24. The rates shall not be finalized after exhibiting/ demonstration of the materials, if required by technical the state. scrutiny committee/ purchase committee.
- 25. The authority reserved the right to reject any or all the bids or part. The decision of the Hospital authority in this regard shall be final and binding on all
- 26. If the prices of contracted article is /are controlled by the Govt, the payment will in no case be allowed at
- higher rate than the quoted. 27. The quantity can be increase or decrease or all together abandoned as per the changed requirement of the department as well as available of the funds.
- 28. Undersigned reserved the right to reject any or all the tenders without assigning any reasons. GMCH does not pledge itself the right of acceptance of the sole or any part of the tender or potion of the quantity offered and the tender shall be required to supply the same at rate quoted.
- 29. Payment schedule: payment will be made after receipt of the bills containing certificate from the concerned store/ department that the items/ materials has be supplied by the firms is fully up to their satisfaction and according the specification and subjected to availability of fund.
 - 30. TDS and other applicable taxes as prevailing rates will be deducted at the time of making the payment.
 - No advance payment will be made any case.
- 32. Details specification of the items should be provided with the price. All the items etc. should be ISO 13485, CE and CLIS us FDA certificate & required WHO certificate whatever applicable should be
- 33. Supply is made from the latest batch of production with the maximum shelf life period & original packing having minimum expiry period of 6 month or more.
 - 34. No revision in rate (On higher size) will be accepted during contract period.
 - 35. No payment will be made for unsatisfactory supply.
 - 36. In case a proposal is accepted the firm shall sign an agreement with the authority for rate contract.
- 37. While submitting the tender document, the tender should specifically sign on each page of tender
- 38. Photocopy of price list and price in spiral binding will not be accepted.
- 39. Authorization certificate from the Principal is mandatory of the rate contract proposal is submitted by authorized stockiest/ dealers.
- 40. The bidder should enclose the duly filled format as Annexure-I & Annexure-II in technical bids.
- 41. The bidder should quote the rate as per format as Annexure-III in price bid only.
- 42. The Hospital authority reserve to impose any other condition for regulating the contract in public interest.
- 43. All disputes are subject to the jurisdiction of courts in Guwahati and agreement will be governed by and be construed in accordance with the laws of India.
- 44. Interest firms/ parties will have to submit unconditional acceptance to the above terms and conditions at the time of submission of the bid on the letter head of the firm.
